<b>CERTIFICATION OF GOOD STANDING WITH RESPECT TO CHILD SUPPORT PAYMENTS AND THE VERMONT DEPARTMENT OF TAXES</b>	
<b>CHILD SUPPORT PAYMENTS</b> A license may not be granted or renewed in the State of Vermont unless the licensee certifies that he or she is in good standing with respect to, or in full compliance with, a plan to pay any and all child support payable under a support order as of the date the application is filed. Good standing means that less than one-twelfth of the annual support obligation is overdue; or, liability for any support payable is being contested in a judicial or quasi-judicial proceeding; or, he or she is in compliance with a repayment plan approved by the office of child support or agreed to by the parties; or, the licensing authority determines that immediate payment of support would impose an unreasonable hardship. (15 V.S.A. §795)	
<b>TAX PAYMENTS</b> A license may not be granted or renewed in the State of Vermont unless the licensee certifies that he or she is in good standing with the Vermont Department of Taxes. Good standing means that no taxes are due; or, the tax liability is on appeal; or, the taxpayer is in compliance with the payment plan approved by the Commissioner of Taxes; or, that the licensing authority determines that immediate payment of taxes would impose an unreasonable hardship. (32 V.S.A. §3113)	
<b>TEMPORARY OR FINAL ABUSE PREVENTION ORDER</b> Licenses and renewals will not be granted to any applicant that is the subject of a current temporary or final abuse prevention order in any state or Canadian province.
