

About DPS “I Speak” Cards

By law, organizations that receive federal monies must provide language access services to individuals who are Limited English Proficient (LEP).

As a recipient of federal funds, the Vermont Department of Public Safety is required to provide reasonable language access at no cost. These laws are meant to provide all people with equal access to public services, programs, and activities.

“I Speak” cards can be used to help an individual obtain language access.

“I Speak” cards are bilingual cards with printed information about Language Access Rights, as well as a statement that requests an interpreter in an individual’s preferred language.
