I. Approval of Meeting Minutes

III. H.626, An act relating to animal welfare

Chair Holm updated board members about the status of H.626 procedurally and logistically. Chair Holm reported that the Vermont Humane Federation has retained The Necrason Group, as its lobbyist. The assigned lobbyist is Teo Zagar, who issued a press release today, January 16, 2024. Chair Holm is listed as a contact in the press release.

Chair Holm indicated that she may be contacted by media and that she would do her best to walk a very fine line about whether she is speaking on behalf of the humane society, the Vermont Humane Federation or ACIAB. Chair Holm said generally she will speak to the work the ACIAB has done in the past.

To date, the bill has not been scheduled for a hearing.

The Senate companion bill has yet to be introduced.

Thomas "Mike" Scott reported that the Department of Fish and Wildlife has not taken a position on the H.626.

Kristin Haas reported that to date the Agency of Agriculture, Food and Markets has not taken a position on H.626, although, the Agency's leadership is meeting on January 17, 2024, to discuss the bill.

IV. Public Comment

Dana Dean, Vice President, Vermont Federation of Dog Clubs, thanked the Board for allowing her to attend the meeting, looks forward to working with Mary McFaun and the Board on H.626.

V. Future Meetings

Chair Holm raised the issue of setting a March meeting date. Board members suggested the meeting date should be set before the legislature's crossover deadline. The House crossover deadline is March 29, 2024.
