And in this case, the content of that draft RFP would put the task force at a substantial disadvantage.

The task force is seeking legal services for providing general legal services to the task force, including compliance with open meeting law and advising the task force during executive sessions of its regularly scheduled meetings advising the task force regarding municipal law, intermunicipal agreements and municipal relations generally as applicable to the task forces duties set forth in sites the law. Assisting with recommending and developing governance structure or structures for multi member municipal entities seeking to provide regional dispatch services consistent with the law.

The Big bill, which instructs the task force to develop findings and recommendations. It goes on to quote the law examples of potential structures.

May include union municipal districts, interlocal contracts, fire, mutual aid Systems, County Sheriff contracts with member towns and or municipal regional planning districts.

Legal experience in the following areas is desired.

One advising Vermont municipalities on issues of municipal governance and administration to familiarity with Vermont police, fire or emergency medical provider legal structures and operations 3.

Familiarity with other intergovernmental structures identified above, or familiarity with state or federal grant administration and the state RFP process, including compliance with Vermont grant requirements set forth by the Agency of

Administration and five compliant with the open meeting law and related topics affecting public bodies in Vermont.

That is the scope and the rest of it appalled, and it sits right inside the template from the procurement office, and I would welcome feedback at this point from Task Force members.


