Regular Meeting No. 20 – Meeting Minutes

February 28, 2024 Via Microsoft Teams

11:32 AM - Call to Order

Co-Chair Neal brought the meeting to order and conducted roll call for Task Force members. She reminded the attendees that the meeting was being recorded.

Approval of Agenda

Mike Doenges entered meeting at 11:36 AM

Motion: At 11:37 AM, Co-Chair Morrison motioned to move public comment ahead of approval of the minutes on the agenda; 2^{nd} by Jim Mack. Motion passed unanimously.

Public Comment

Co-Chair Neal opened the floor to public comment.

Ray Gorman of Northern Borders Dispatch shared with the group that their entity will be applying for a grant for approximately \$900,000 through the Northern Regional Borders Commission in hopes of completing a major upgrade to their dispatch center in the North Country. He shared that among other smaller components, this upgrade would include significant improvements to their mapping technology.

Mr. Gorman shared that their entity is looking for a letter of support from the Task Force to submit alongside their application, with a preliminary application deadline of March 15, 2024. He shared that their dispatch center is responsible for covering a large portion of the North Country, including several towns in Vermont. The group at Norther Borders Dispatch hopes to initiate a solid working relationship with the Task Force, and to have further future discussion of the possibility of adding a tower on Mount Monadnock in Lemington, VT, as it could assist in coverage through many of Vermont's towns.

Co-Chair Morrison thanked the members from Northern Borders Dispatch and shared that this conversation in regard to the letter of support could be continued offline, and she would bring any draft language submitted to her or Corey Chase back to the Task Force for further discussion on next steps. Co-Chair Morrison also noted that as work continues in planning what the future system for Vermont might look like, there will be continued conversations with neighboring communities who will be affected as well. She asked that the group stay in tune for future developments on the matter.

Stephen Whitaker began by discussing his initial interactions with attendees from Northern Borders Dispatch regarding their lack of mapping capabilities. He stated that despite Vermont E911's advanced capabilities within their dispatch facilities, he did not feel that all facilities throughout the state have been provided the same benefits. Mr. Whitaker shared with the group that he told staff from Northern Borders Dispatch that he did not feel the Task Force was able to move as quickly as their entity might hope.

Mr. Whitaker continued on to share the following comments in regard to the Draft Planning System Project Plan circulated prior to the task force meeting:

- While there is what he believed to be some pertinent information, he did not feel that the draft document reflected a thorough plan.
- He reiterated his prior concerns with Task Force due diligence in the selection of the project management team.
- He shared concerns that a project scope definition for LMR, LTE resiliency, redundancy, inventories, or financial models was not presented in the draft plan.
- He shared concerns regarding the timeliness of plan development.
- He shared that he feels there is not adequate capacity on the task force to manage the project manager.

• He shared that instead of waiting for the hiring of SME's, the project plan should already be developed when they come on board.

Mr. Whitaker continued on to share the following comments in regard to the Draft Congressionally Directed Spending (CDS) Implementation Plan:

- He shared that he believes the current proposed use of congressionally directed spending is at great risk of being found an impermissible use from the congressional intent to support the transition to regional statewide communications, public safety communications and this is in effect building up the state systems when there has yet to be an agreement on who is going to use the system and under what circumstances.
- He stated that he believed the \$9 Million in CDS is corrupting the process, and shared concerns regarding statutory planning and independent review requirements.

Approval of Minutes

• 02/14/2024 – Regular Meeting No. 19

Motion: At 11:50 AM, Jim Mack moved that the task force approve the minutes as written; 2nd by Jennifer Morrison. Motion passed unanimously.

Project Status Report

Co-Chair Morrison shared that the weekly status reports were circulated to Task Force members, interested parties, and posted to the website prior to the meeting. She then opened the floor to Task Force members for feedback on the format of the reports.

Co-Chair Neal shared that she approves of their current format and enjoys seeing them from week to week.

Mike Doenges shared that the current format is working for him but felt as though the Task Force could leave this open for discussion at a later day as the project progresses.

The Chairs asked the project management team members if they had anything further to share. Dom Arcuri shared that there was nothing further, but that the team remained open to future suggestions to meet the group's needs.

Draft Project Plan Review

The Co-Chairs opened the floor for input from Task Force members on the Draft Project Plan circulated prior to the meeting. Co-Chair Morrison began by remaindering attendees that this document does not represent a finalized plan and will not become finalized until the subject matter experts are brought on board and are given the opportunity to develop a collaborative and unified plan.

The following comments were provided by Task Force Members:

Mike Doenges noted that he appreciated this process. He acknowledged that individuals through public comment have shared their concerns with the pace of the project thus far, however Mr. Doenges noted that given the complexity involved in the tasks at hand, it is imperative that the Task Force take their time to ensure that this process is done properly and fosters a much better long-term outcome in vision for the state.

Mr. Doenges continued on to share that he appreciates that the Task Force understands the urgency in which this project does need to be done, and that he believes the Task Force is doing the necessary due diligence by ensuring the group does not jump ahead and create multiple plans for multiple things until all of the parts are in order. He shared that he believed the Task Force is headed in the right direction and is moving at the pace necessary to be successful.

Ron Kumetz contributed to Mr. Doenges' comments by sharing that as a representative of both the fire service and from a technical perspective, the steps in which the Task Force have taken thus far are necessary to build the buy in from local jurisdictions. Mr. Kumetz shared that the State of Vermont has approximately 253 fire departments, the majority of which are volunteer departments. He shared that from his experience that if these departments feel as though the Task Force is trying to force something on them, chaos is sure to ensue.

Mr. Kumetz reiterated that it is imperative that the group take their time to foster solid working relationships with the stakeholders and truly understand the individual needs and have important conversations about what might need to happen. The Task Force wants the stakeholders to participate willingly and not feel forced.

Co-Chair Neal echoed Mr. Doenges and Mr. Kumetz comments.

Co-Chair Neal noted that while on the topic of stakeholder engagement, there was an item she would like the project management team to discuss under new business.

Draft CDS Plan Review

Co-Chair Morrison provided a brief overview of the draft Congressionally Directed Spending Implementation Plan and solicited feedback from Task Force members. Co-Chair Morrison shared after gathering and incorporating appropriate feedback in the draft CDS plan, the intent is to resubmit the plan back to the federal agency, where they will also request an extension of the period of performance by 18 months. Co-Chair Morrison stated that without the period of performance extension, it is very possible that all of the outlined work in the plan may not be completed.

Co-Chair Morrison explained that the current draft of the CDS plan has been developed to do two things; be allowable under the COPS technology funding stream, and reflect the intent behind ACT 78, which is to build the strongest possible backbone to be best positioned with the most recent technology, allowing for successful implementation of whatever system design is decided upon at the end of this process. She shared

that the draft plan outlines the possibility of two new sites in the area of Canaan and Ferdinand which would hopefully benefit the North Country area as previously discussed in this meeting.

Co-Chair Morrison opened the floor to comments from the Task Force members on the draft CDS plan and requested that any additional feedback outside of the meeting be submitted via email to her or Corey Chase, Director of Radio Technology Services by the end of the following week.

Mike Doenges thanked Co-Chair Morrison for the opportunity to review and weigh in on the draft plan, and expressed his overall gratitude for the approach that was taken in developing this plan. He shared that as a network engineer who has designed infrastructure and backbones for different systems like this one in the past, the use of congressionally directed spending in the way it has been provided will hopefully allow for the development of a successful system that serves the bigger picture. He reiterated his appreciation for the effort that has gone into the decision-making process and shared that he believes core infrastructure is critical to the States needs moving forward.

Mr. Doenges stated that he did not have comments to add as he believed the team who developed the plan had done a phenomenal job and is excited to see what the final version of this plan will look like.

Co-Chair Morrison gave credit to the whole team responsible for developing the plan as they did a great job.

Co-Chair Neal asked one clarifying question about the language outlined in Plan Project Nine (9) regarding dispatch improvements and consoles. She added that her understanding of dispatch consoles is the actual workstation where all the equipment sits that allows the dispatch function but felt while reading through the proposal that console may mean something a bit different and asked for further clarification.

Corey Chase clarified that a dispatch console is a device that is at a call taker workstation that allows the dispatcher to communicate over the radio network. He went on to explain that it is his understanding that presently at the Vermont State Police (VSP), there are dispatch consoles that are PC based and have a touch screen that allow the call taker to push a button and select which radio channel they wish to speak over when using their microphone to speak over the radio network. For the purposes of this particular project, they are proposing an upgrade to the current dispatch console to a device that provides similar functionality, but also includes an embedded voice telephony service in the same device to hopefully eliminate aging desktop analog telephones that are integrated for the current single use headset.

Mr. Chase shared that presently VSP dispatchers are required to use the same headset to speak over the telephone and to speak over the radio, which causes added frustration to all parties in maintaining the quality of the service when both the analog telephone and the technology is aging. He explained that the intention is to upgrade the dispatch consoles to integrate modern digital telephony into the same device headset that can work in a single system that can seamlessly integrate between telephone calls and dispatch functions. He also shared that once this service has been successfully integrated into VSP and shows promise in easing their operations, it has an ancillary benefit and is something that is easily extensible.

Mr. Chase also shared that this modern technology would allow for dispatch operations to become portable should the need arise.

Co-Chair Morrison briefly touched on the statewide benefit of this system as the two current VSP PSAPs handle roughly 75% of the 911 calls and then get them where they need to go. Co-Chair Neal provided clarification that it is currently just shy of 70% of the calls, however still very significant.

New Business

Co-Chair Neal opened the floor to Rick Burke, of Televate to share a conceptual idea with the group as it pertains to stakeholder engagement.

Mr. Burke shared that the project management team has begun drafting what they have preliminarily referred to as a stakeholder update or newsletter. The project management team asked to use this time to solicit feedback from the group on the concept and shared a draft of the proposed format on the screen for attendees to view.

Stephen Whitaker asked that a copy be shared with him via email; Co-Chair Neal acknowledged the request and stated she would send him a copy.

Mr. Burke provided a brief overview of the proposed first edition draft of the stakeholder newsletter to include the following items: project details and overview, 'Did You Know' section introducing stakeholders to public safety communications, team introductions, project status of current and key activities, introductions to project management team members, and a section providing stakeholders guidance on providing direct inquiries to the Task Force.

Co-Chair Neal opened the floor to comments from the Task Force members.

Jim Mack shared that he liked the idea.

Co-Chair Morrison stated that it was a great first draft, and that she appreciated the thought behind it. Ultimately, she is interested in what the stakeholders think and proposed adding a feedback section for stakeholder comments. This may entail a shared mailbox being created for submissions.

Task Force members discussed the desired frequency of the newsletter publications, and the majority agreed that monthly would be appropriate.

Mr. Burke shared that he would work on some edits and hoped to distribute another draft to the Task Force for comments later in the week.

Executive Session – For the purpose of discussing one or more contracts

Motion: At 12:28 PM, Co-Chair Neal moved that the Task Force finds sharing information about bidder responses publicly would put the task force at a substantial disadvantage in making a decision about

awarding a contract or contracts; 2^{nd} by Mike Doenges. There was no discussion and the motion passed unanimously.

Motion: At 12:29 PM, Barb Neal moved that the task force enter into Executive Session for the purposes of discussing one or more contracts and invite members of the Televate project management team; 2nd by Ron Kumetz. The motion passed unanimously.

Executive Session was entered at 12:29 PM. Task Force Members Barb Neal, Jennifer Morrison, Ron Kumetz, Jim Mack, Mike Doenges and clerk, Cally Audet attended, as well as Televate representatives, Rick Burke, and Dom Arcuri.

Motion: Ron Kumetz moved that the task force exit Executive Session; 2^{nd} by Jim Mack. The motion passed unanimously.

Executive Session ended at 1:01 PM.

Potential Action(s) as a Result of Executive Session

Motion: At 1:03 PM, Co-Chair Morrison moved to return the draft contract to selected vendor with the modifications as discussed in executive session, and if accepted by vendor it shall constitute approval of the contract by the Task Force; 2nd by Ron Kumetz. There was no further discussion and the motion passed unanimously.

Set Next Meeting Date and Adjournment

The next meeting is scheduled as a regular meeting on Wednesday, March 13, 2024, at 11:15 AM.

Motion: There being no further business, Mike Doenges made a motion to adjourn; 2^{nd} by Jim Mack. There was no further discussion and the motion passed unanimously. The meeting adjourned at 1:04 PM.
