Legal RFP Status

Co-Chair Neal advised members that there weren't any responses to the legal RFP. Members discussed reissuing the legal RFP and reaching out to legal professional contacts and/or organizations to get the word out about it being posted. Stephen Whitaker suggested that members should reach out to the Vermont League of Cities and Town, as well.

Motion: Mike Doenges moved that the task force reissue the RFP for legal services on as many sites as possible; 2^{nd} by Paul White.

Discussion: Co-Chair Neal proposed amending the motion to include soliciting the assistance of appropriate professional organizations to get the word out; members agreed. There being no further discussion, the amended motion passed unanimously.

Little RFP Next Steps Discussion and Big RFP Responses Evaluations

Motion: Co-Chair Neal moved that premature general knowledge of bidder presentations and responses would put the task force at a disadvantage in making a decision about awarding a contract to the successful bidder in both RFPs; 2nd by Paul White. There was no discussion and the motion passed unanimously.

Motion: Co-Chair Neal moved that the task force enter into Executive Session for the purpose of discussing the little RFP next steps and the big RFP response evaluations; 2^{nd} by Jim Mack. The motion passed unanimously.

Executive Session was entered at 11:12 AM. All task force members present and acting clerk Soni Johnson attended.

Motion: Jim Mack moved that the task force exit Executive Session; 2^{nd} by Mike Doenges. The motion passed unanimously.

Executive Session ended at 11:42 AM.

Potential Vote Regarding Next Steps for Little RFP and Big RFP

Motion: Mike Doenges moved that the Task Force schedule a special meeting for 11/17/23 @ 9:00 AM for review and presentations of the big RFP and discussion of both the little and big RFPs; 2nd by Jim Mack. Discussion: Paul White asked if the questions would be handled as they were for the little RFP presentations (questions were not submitted to presenters in advance). Answer: Yes, the questions will not be provided to presenters in advance.

There was no further discussion and the motion passed unanimously.
