Workshop planning meetings.

I'll just give a little introductory stuff here.

On each of those things, and then we can discuss where things stand as we go along. So the regional town halls, as you know, have all been completed.

Mission critical is continuing to slice and dice the data we gathered from those town halls, along with the information, of course, that they received from the questionnaires that were sent out to dispatch centers. Also on the regional town hall follow up.

I know that Rick and Dom have had.

Some follow up conversations with individuals from those those meetings to better understand specific issues and or perspectives.

Anything from anyone else to add on the regional town hall topic? OK.

Then let's turn to the planning for the two community listening sessions.

These are the sessions of course, that are intended to engage directly with the public. We have the two sessions scheduled actually for next week, so October 22nd, which

is Tuesday from 11:30 to 1:30 and then again on October 24th from 6:00 PM to 8:00 PM.

The announcements went out about these sessions.

Via the DPS Department of Public Safety Communications team, there were social media posts, e-mail distribution list.

We used a front porch forum distribution to hopefully engage with many, many thousands of people.

I did find that Front Porch Forum announcement in in my town's front porch forum on the October 14th issue, but I think it was going to hit at different times starting last Sunday.

So Barb, I just want to jump in there and say that the deal with Front Porch Forum, which was not inexpensive, I'd like to point out is that it will, it will come up in various feeds until it reaches 648,000 views that.

Basically a view for every citizen in the state.

So hopefully that's effective, but I also really want to make sure that folks on this call and beyond are clear.

That there is going to be a third listening session, so a couple things with the date is not nailed down, but it will be in November, probably towards the end before Thanksgiving, but.

I think it's gonna be the week of the 18th, but we don't have a date yet. And that will be.

Advertised slightly differently, not not necessarily. With the same to the same audience, but we have added American Sign Language interpretation for the

meetings next week.

So we have interpreters lined up.

They are looking for direction from mission critical on how to access the meeting and they there was small requirements they needed to be able to be able to be pinned for the people who wanted to be able to.

Watch the interpreter.

We've also changed the landing page for the two sessions to ask if people have language access needs, and if so, to identify what language they need.

And we're going to take that information if there are folks who need accommodation.

There is a closed caption.

Ability to be translated in one of many languages on the platform.

It's not ideal.

So for that third session, we're going to invite anyone with language access needs, and we're going to be translating the announcement of the meeting and sending it to groups that we know have interest and and work with people who speak their first language is something other than English.

So that we can try to.

Engage this population, which is a vulnerable population when it comes to emergency communications, and make sure that we hear what they want.

From a future emergency communication system. So there is a lot of work behind the scenes on my team happening relative to being accessible to anyone, particularly more vulnerable Vermonters, and there will be a date and time announced for a third listening session that will have as many trans.

That we as we need and they can all be in separate breakout rooms, but participating in the meeting.

And the and the meeting content in real time.

So stay tuned for more detail on that.

So we also alerted all of the media weeklies dailies.

Print, radio and TV, so I'm not sure what else we could do to get the word out, but if folks have ideas, we we ask the Vermont League of Cities and Towns to send it to all town managers and town administrators to put into whatever communication they push.

Out. So if you guys have other ideas, happy to pursue them. But we we really tried to get the word out there.

Yeah, I think I mean another Ave. is through the Regional Planning Commission's, but I think they're only going to push it to the same group that the league of Cities and Towns pushed it to to the town officials.

From previous regionalization attempts, hopefully to identify and avoid.

Any potential pitfalls that others have encountered, or at least know what the pitfalls we might encounter are?

So that was one idea.

There's also a question around.

When do we do these workshops so that you know what is the discussion point? Is it going to be what mission critical has come up?

With for.

As they are bringing the the development of the potential plans together or where are we with that discussion?

So, Jen, you had some other thoughts on this?

Do you want to add something here?

# Morrison, Jennifer 18:35

I thought that the timing of the sessions.

Probably made sense to be thoughtful about, for instance, one of the sessions we

had discussed having those lessons learned from prior efforts to regulate, and it seems to me like that should be the first workshop we hold, right, so that we can not repeat.

The OR try to find solutions to some of the roadblocks and that's recognizing some of that information in whatever report.

Comes at the end of this process that that's included. I mean for instance, it is a very real problem to try and take multiple existing communication centres and smash the personnel together who all have different.

Labor unions or contracts, conditions of work, salary, seniority, how they bid for shifts.

The logistics of bringing personnel together in a new entity I know is a formidable 1. So I think to me it makes sense to have that type of workshop 1st and get those lessons out there so we can start either problem solving or at least recognize them in.

The report.

The order of play.

Beyond that, I didn't have a lot of input into the middle, but.

There had been a suggestion that the workshops on what you.

Users end users want for a CAD system would be the first ones out of the gate and in in my mind those are the last ones out of the gate.

That is an operational level window dressing that is not foundational to creating a regional or statewide emergency communication system.

So that my my two cents is that the CAD would be at the end. The lessons learned would be at the front and then whatever other individual workshop topics this group decides is most appropriate would be.

In the middle.

OK, great. And some of those other topics that have been brought up, so we've talked about the lesson learned topic and the CAD topic, which maybe should Jen suggestion at least would be for it to go at the end. We've talked about a telecommunicator focused or operations focused.

Workshop, you know, directed at supervisors, dispatchers, call takers.

Maybe at two different sessions for, you know, director level and.

On the front lines level, that would cover staffing, training, operational standards,

that type of thing.

So that's that whole spiel was one topic.

Telecommunicator focused coverage topics.

So coverage LMR cellular or perhaps separately?

And interoperability is another topic. Governance funding.

So let's start. Let's start here.

Does everyone agree that lessons learned would be a good first first stop?

Well, the the initial contract says that.

The inventory report should be done by October 25th. I I believe that we have heard that there may be a request for an extension, but I have not received a request for an extension on that.

Let's just say it's the it's two weeks later than that and it's no, whatever.

That would be November 6th, 7th, something like that.

So that means that any subsequent workshops other than the one we just talked about on lessons learned would logically happen after the date.

Because I agree with you, Barb, that until we can look at the landscape as it exists today and understand all of the, the picture that MCP has been pulling together, it's gonna be difficult to have.

Fact based conversations about the current status.

Of LMR coverage, cell coverage and other things.

The the only other topics like workshop topics that I suspect could happen before we see the data are if we were going to do one specific to brainstorming governance models.

Or one specific to brainstorming funding models, so those.

Two topics I'm not sure we need to be dependent on seeing the inventory and the you know the the.

The data collection.

But the other ones strike me as we do need to see that before we get too deep into them.

Would we need the information from the questionnaires and the input from the town halls to support the OR not to support, but to lay that foundation again for the governance?

I mean, we'll learn about the various forms of governance out there.

# James Mack 26:27 Thank you.

# Neal, Barbara 26:28

From that and about the various funding mechanisms.

But you're not seeing that it would necessarily be worth waiting for that. Is that what I'm hearing?

I think that the the information about governance and funding are not going to come from the town halls because I don't think we dove deep enough into how each of the existing entities bill or.

Maybe that information is coming from the surveys.

# Morrison, Jennifer 26:58

Maybe that's coming from the on site visits. I'm not sure so.

I guess what when I think about the funding mechanism, I don't necessarily think about how any one agency is doing it.

I think about how this as a state not not just a state entity, but across the entire state. How should we be doing it in an equitable and sustainable manner? So I guess I was thinking bigger than the current landscape.

Well, and it wouldn't. Yeah, exactly.

It wouldn't limit our discussion to the current landscape. There may be other.

Other ways to to do that?

So I I don't.

I guess I could.

I could see those happening before as well.

Before the data is is altogether.

So so I made that note governance and funding after lessons learned.

As two separate workshops.

Is that the intent or do we want those together?

I think this the people that you pull in for subject matter expertise are gonna be very different for funding.

I think some of them it will be, you know, like talking about the very first one. It would be difficult to maybe not difficult, but it it won't be necessarily easy to get everybody together in person if we're talking about lessons learned in Chittenden County, lessons learned in.

Washington County lessons learned in Lamoille somebody's going to have to travel and will add to the difficulty in in coaxing people to come.

Yeah, I think there's a a valid discussion to be had about whether in person makes sense given that we're trying to pull people from all corners of the state. So totally open that to that discussion.

I think they're a lot more roductive, but when we're begging for people to come participate in our discussions, we may have to make it easier for them to get there.

I would. My preference would be virtual. For that reason, I think it encourages participation.

Really, I would suggest that for all of them, I think.

Ask for members. Agree or.

I don't have a choice now. I think everybody's in that mode of trying to. Everyone is doing so many meetings now that you know it's impossible to get to everything in person.

So you I think you have to have a blend of in person and virtual.

I think we're in the world now that you know, we just were forced to, even though I agree too in person, is a preferred option.

But I think we're beyond that and especially as a statewide, having a statewide meetings, I think it would be impossible to think.

Gonna get anybody there to to the in person ones.

Mm hmm.

So frankly, that serves.

That saves a lot of logistics in the sense of booking rooms and all of that too. So you know you have a meeting and it's it's virtual and that's that.

Are we ready to make a decision about who's adopting which topic, or do we want to think about that and revisit next meeting?

That we do anticipate getting further information on the outline and that information towards the end of this week and we'll certainly pass that on.

When? When? That's when that's received.

In terms of the.

Taking a guick look at the overall schedule.

I'll I'll share that. As I mentioned, well, of course we have completed the the workshops and the site visits we are currently in the analysis phase where we're analyzing and accumulating all that data.

I know the data from the data questionnaires, the 32. I believe that we received.

Were has been all consolidated and that is being analyzed.

And the primary item on the schedule is the delivery of the system inventory and

assessment report. As Jen mentioned earlier, the requirement for that via the contract is 25th of this month.

Starting to feel a little bit of pressure on that on that date given we don't have a draft at this point, but we are hopeful that that will be.

Along quickly, we have identified the Community listening sessions on here and then. A tentative schedule for the workshops.

That'll probably be pushed out as we mentioned into the November time frame. So I'll look to update that over the next couple of weeks.

That is where we currently stand. And as I mentioned, ongoing efforts, you know, over the next couple of weeks prior to the next meeting, we'll we will hold the Community listening sessions and have an outline, hopefully a draft of the inventory and assessment report and continue that \*\*\*\*.
