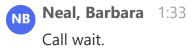

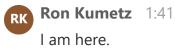

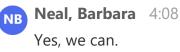

Our focus over the last few weeks has been primarily on the reports for the project. Report deliverables. Both the inventory and assessment report and also development of the system planning report. The inventory and assessment report has gone through review and comment period.

The comments have been addressed by MCP.

They have updated the document and it is ready now for distribution to the individual dispatch centers.

The plan for the that report at this point is to.

Actually break it up into the individual section so each dispatch center will receive the introductory sections.

Believe sections 1-2 and three.

To give them, you know, contacts. Of course for the report and then their individual section that assesses the specific.

Capabilities and current situation in their dispatch center. They will have that to review to confirm the data is accurate and also there are some areas where we have gaps in the data.

Hopefully they will be able to fill that in so that.

That will be going on.

Maybe Jason can give an update as to when those are being sent out, but hopefully this week and we'll be getting back updates and incorporating those. In parallel.

Mcp has been working heavily on the system planning.

Report, which is the major, you know, final report deliverable of the project.

We have that schedule.

For a first draft this week.

The on the 10th Friday, we have scheduled the first draft of that report, which will be available then for Task force review and comment. I assume we're going to make that available in a similar fashion if we do the inventory and assessment report so that it will be.

A link will be provided where Task force members can go online and review that and provide comments via a comment sheet.

Our intent is to incorporate those initial comments.

Get a second draft towards the end of January, which we can distribute for.

Further review from.

Broader selection of stakeholders as well as the public.

In addition to those activities we have, we have completed I think we reported last time completed all the workshops with the exception of the funding.

A workshop which we have been waiting until we have some.

Budgetary numbers that we can communicate to the funding group, we should have those soon with the draft report.

So that's something that actually we need to we need to schedule and maybe we can have discussion later during this meeting as to when best to schedule that meeting. So a lot of activity going on.

I think that summarizes the majority of it.

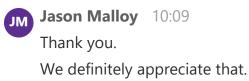

You have no right, because when we don't know.

There's so many variables right at this point that we can really identify some things that are more.

Labor intensive, you know, oriented than rather hard costs. But when we're talking about existing 34 communication centres or potential mergers, what those regions could look like, who would you wear that again?

Where even some of that funding could could come from.

Who would actually ultimately be the the?

I would say the players, but those that would want to merge versus those would that would want to stay independent.

Those are a lot harder costs to.

I mean, there's just so many configurations of what that could be.

So those are conversations that that we wanna have and I would look at this in many cases more of of a ROM until a path is determined.

Once a path is determined.

Or the options and. I know that the some of the task force members you know as we work through, we've seen you've seen some of those options.

Uh.

And you can start to refine a cost much more in the cost today is going to be different, much different than a cost five years or seven years or 10 years down the road when some of these things could take place so.

There are so many variables I I just want to kind of set expectations.

It's not like this would be a line item.

You know, on that you would get, you know, with a contractor on a facility built so. And where those funds could come from and when funds could be available down the road, that may not be available today, so.

That's there's just a lot of variables.

So we I know we have another conversation coming up as we get set to to bring things together for Friday and these are some of the things we probably need to talk about.

How might these be funded?

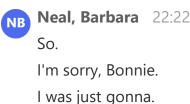
What are things we should know?

We know what that general number is right for the 217 existing.

Equivalent with troops. I think about 19,000,000 as being spent on staff.

Estimate at this point.

Wide now that compared to when we calculate out the potential staffing numbers for if we do a reduction for the options for the reduction in communication centers, those options, those four, those are numbers that we'll be able to to present. We know this is a cost we know.

This could be a future state 1234 options for.

A change in the number of staff.

And we can show the delta there. If you did. This is the current expense. If you did this, this would be reducing that number.

This would be reducing that number and through those savings you could see a potential path and a funding source to get to a a future state. Somewhere along that continuum, those types of things we can to say.

In Jason, as he mentioned, another example would be, you know, estimates on what would a CAD look like.

Again, future State 37, but you know we don't know.

Then what? The other options for mergers would look like, right?

So seat licenses, things like that, we'll be able to give a general number, but like you just said, the devil's in the details.

Of like we, we have budget information from a majority of the communication centers today.

So perhaps again, if said these three centres over here just hypothetically decided that they were gonna merge and be, you know, a regional center, we know what their existing budgets are and what that could potentially be.

Duplication of effort or reduction in those costs, network costs potentially. I think that's something we would need to know.

Like what are the what are the costs that the state perhaps is paying already? And get more granular.

I don't think we can get as granular yet to say, well, what would be the savings in network costs and things like that.

We can show that their budgets, even if they need to keep on staff for walk up windows or other ancillary duties, jail duties, that kind of thing, that that a large portion of their budgets, that their municipalities are currently spending. Could be, you know, spent elsewhere and had a more efficient cost, not even to talk about in that the the saving in like reduction in call transfers and things like that where you really can't really can't put.

Wouldn't say you can't put a monetary value to those.

They are a time savings, but you know there's there is that element as well. We want to talk about it's there's a lot of funding and cost discussions, cost sharing is another piece. We wanted to kind of lay out options, cost sharing elements in there, but there also there's operational efficiencies that we want to focus on as well.

Regionalization and what savings you have in one center or what investment you have to make in spanning centers, there's a lot of moving parts here. And so whatever our assumptions are, you know whatever the the assumption underlying assumptions, the radio network and for backhaul and for all the.

So one of the things that I wanted to bring up is that I've been, I've been talking to some people in the fire service and it appears that, you know, part of this problem that we're going to have is.

People don't actually understand or have not like completely read the instructions. An example of this is that I was approached by someone who went to one of the county mutual aid group meetings.

And some of the people there were upset because their agencies had not been surveyed about dispatching yet.

The dispatching and I put that in the air quotes and that kind of thing that they do is consists of sending the oldest guy in the fire department down to the station after their tones have gone out and the trucks have rolled out. And somewhere along the line.

They feel that that's dispatching and so.

I think what we're going to get to.

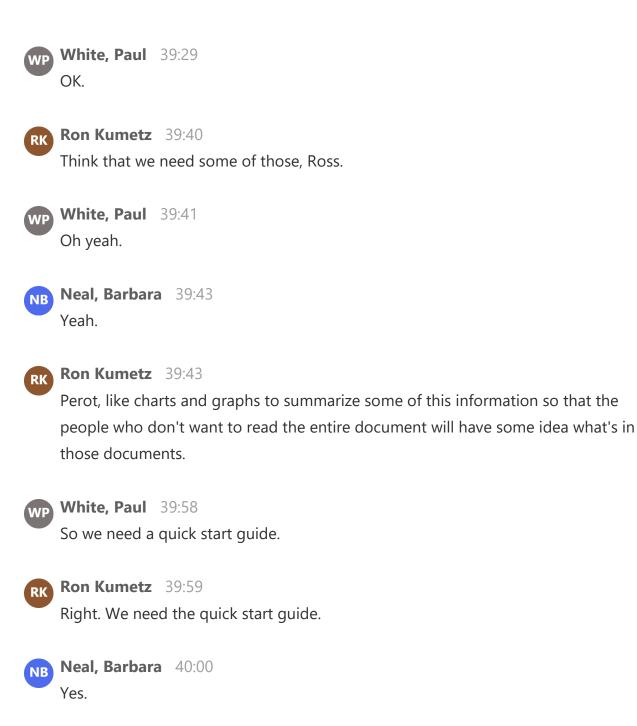
Is that we have these huge documents and it, you know, it's hard enough to get anybody to open their various new appliances and read the single page.

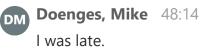

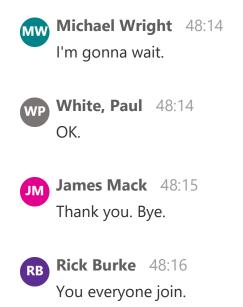
