And then what we want to do be able to give you some different models about how you could go to the future.

So, you know, nine, probably 70 or I would almost guess 75% eighty or 90% of your call volume was coming from cell phones most likely and they called from 911 to report their incident.

Automatic crash notifications.

There's even to the point now that the the wearable devices, if it senses something on your body, is not right, it can automatically call 911 for you as well.

So all these things are going on as far as reporting the incident, but we need that information to come in and then to flow over to the communication center itself.

You know that that call gets taken care of and that information from that call for that we talked about records management system or even the jail management system and making sure that information gets all the way through that process and gets to any of your partner agencies that needs that information or be able to follow up on that.
