**DPS Violent Crime Report Request**

Part of Governor's 10-point plan. Want to be allowed to pull all data for entire state.  
Incidents requesting: arson, assault, burg, homicide, sex offense, kidnapping, domestic violence, narcotics, robbery  
Article 8 of VGB charter approves general info being released  
DPS has asked for *common call type, city, street name (not number), date/time, weapon, incident code*;  
State is looking to map all incidents.  
What is the state looking to get? Want to see the global picture for the state. Mike's understanding is that they are not going to be going through and attaching specific incidents per dot on map, want to try to track global picture of state.  
Step 8 of the 10-point plan is to apply the pandemic playbook to public safety, data driven and get the resources where they are needed as soon as a trend is spotted. (Jim)

**Dispatch Call Types Report Request**

**Dispatch Call Volume Report Request**

Motion to approve the release of *incident number, ORI name, common call type, and city* by Mark  
Questions:  
Eric – are we excluding locked or sealed incidents? Mark – because including only common call type and all IA would be “administrative”  
Mike – what about drug investigations? Don't want to tip anyone off on ongoing investigations. Is there a way to exclude the drug task force, would that be possible? Vegar – if we remove it from the study shouldn't be much impact because they don't utilize dispatch services. Mark – should be able to
