Eric and Steve – both believe the chiefs will have issue with removing #7 & #8

Mark – VGB is for contributing members and ADS is not a contributing member so they should be a non-voting → Jim response: in contract with State of Vermont, ADS is supposed to be part of governing body, ADS in statute is required to be accountable for system – Mark: use of system itself and the data is the agencies, as an agency head I was perfectly happy paying for our own license and don't want ADS to tell each agency what they are allowed to do with own data. DPS could appoint ADS as their rep since they are part of DPS.

From the State and Crosswind contract: "A Governance Board consisting of representatives from DPS and ADS, the current Valcour Community, the current Spillman agencies and Contractor will be created to manage this plan."

Betty: Could ADS be in an advisement role to satisfy the statute?

Jim: Or perhaps a memorandum of understanding that they will abstain from operational. Contract amendment that leaves the VBG where it is and adds a sentence about including ADS in contractual members.

Adam: To be honest this is confusing having ADS involved. This system is used by the State but not managed in any way by ADS. Does the State offer ADS involvement with other systems that are used. – (response: No this is a unique situation.) Like Betty suggested, would an advisor role fill that need? Think not because it doesn't provide the accountability, since ADS doesn't have accountability over the contractor.

Eric: Have board with an odd number for a reason and if ADS is not voting that could create issue with tight votes.

Adam: if Crosswind changes the authentication process (Soft Token) then how would ADS respond since ADS oversees security? Jim: ADS would keep track of but Valcour has to meet CJIS security so those standards are higher and CJIS would take charge. Most things security CJIS will be the controlling standard, this is more to satisfy the contractual agreement. Example if there was a disagreement on a deliverable, State felt deliverable wasn't provided and VGB believes it was provided then the State is stuck and can't do anything.

Justin: When VIBRS was functioning, ADS had a very active role but they never had a voting role and it worked really well and Darwin had a good portion of the meeting to address any needs.

VSP is under DPS but sometimes have different issues, which is why they would like to to have their own designated representation and not be lumped into DPS.

Common Call Types (DPS Commissioner Morrison)

Discussion about data quality coming out of Valcour. Trying to get a look week-by-week basis about what is happening around the state. One issue is the call types coming in not uniform. Been circumstances that homicides have not been changed in a timely manner. Seems like there should be some way to accurately represent the most accurate call type.

One of the beauties of Valcour is that ORIs can have their own call types but have to be linked to common call types. Example: call type service of APO was being linked to common call of Domestic. This community looked like it had a huge amount of violence domestic crime but actually had a bunch of paper work being served.

Mark: State is paying for this (Valcour) because the state wants the data, so have some interest in getting the most accurate data.

Eric: think it's something that can be fixed pretty quick since Crosswind went through and routed everything and most agencies probably didn't go through and verify workflow.

Betty: some agency don't have call types mapped to any common call types

Com. Morrison – would like a small group to get working on this and come up with a plan within 60 days.

Mark: identify which agencies have issue and start communication with them and work on fixing them Com Morrison: Use Cpt Manley as the resource for this
